MOTION FOR A STAY OF BRIEFING SCHEDULE IN LIGHT OF LAPSE OF APPROPRIATIONS

For the reasons discussed below, the government respectfully requests that the briefing schedule be stayed in light of the lapse of appropriations.

1. The government's opening brief is currently due October 7, 2013. On September 19, 2013, the government filed an unopposed motion for a 10-day extension of time in which to file its opening brief. This Court has not acted on that motion.

2. Appellants are represented by counsel from the Department of Justice. At the end of the day on September 30, 2013, the appropriations act that had been funding the Department of Justice expired and appropriations to the Department lapsed. The same is true for most Executive agency clients with whom the Department attorneys must coordinate their filings. The Department does not know when funding will be restored by Congress.

- 3. Absent an appropriation, Department of Justice attorneys are prohibited from working, even on a voluntary basis, except in very limited circumstances, including "emergencies involving the safety of human life or the protection of property." 31 U.S.C. § 1342. We therefore requests a stay of the briefing schedule until Congress has restored appropriations to the Department.
- 4. If this stay is granted, we will notify the Court as soon as Congress has appropriated funds for the Department. The government requests that, at that point, all current deadlines for the parties be extended commensurate with the duration of the lapse in appropriations.

5. Plaintiffs' counsel has authorized us to state that plaintiffs consent to an extension of up to 30 days for the government's opening brief, if such an extension is needed due to the lapse in appropriations.
